Extended Abstract Submission Guidelines

I. Submission Overview: The 2026 ICSLHM invites submissions of original research for oral and poster presentations. Authors are requested to submit an **extended abstract (2–4 pages)** in either **Chinese or English**.

All submissions will undergo a double-blind peer review process, typically completed within two to four weeks. Authors will be notified of the results individually.

Note: Japanese abstracts are accepted; however, a separate English title and abstract (minimum 300 words) must be included preceding the Japanese text. Please upload them as a single file during submission (the English abstract is excluded from the page limit).

II. Extended Abstract Formatting

1. **Structure:** The extended abstract must be organized in the following order: Introduction / Research Purpose, Literature Review, Methods, Results and Discussion, Conclusion / Suggestion, Keywords, and References.
2. **Page Limit:** Minimum of 2 pages, maximum of 4 pages (including author information; excluding references).
Note: Revised manuscripts submitted for re-review must also comply with this page limit.
3. **Margins:** A4 size; 2.5 cm margins on all sides (top, bottom, left, right).
4. **Font:** Times New Roman for English text.
5. **Title of Paper:** Bold, 14pt, fixed line height of 22 points. English titles should capitalize the first letter of each major word (excluding articles and prepositions). Submissions in Chinese or Japanese must include both the Chinese (or Japanese) and English titles.
6. **Authors:** Place author names below the title using 12pt font and single line spacing. Include affiliations and job titles. For multiple authors, use superscript numbers to indicate affiliations.
7. **Main Text:** Font size 12pt, single line spacing, justified alignment. Section headings must be **bold**.
8. **Keywords:** List up to 5 keywords at the end of the text, before the references.
9. **Figures and Tables:** Must include titles, numbering, and brief captions (12pt), placed appropriately within the text
10. **Page Numbers:** Page numbers should be centered in the footer using 10pt font.
11. **Reference:** Follow the **7th Edition of the APA Publication Manual**.
